Rail Overview

California is home to dozens of passenger, freight, and commuter rail lines, as well as rail suppliers. California ranks 5th in the country for the total rail miles and 4th for the number of freight rail employees. It's also home to some of the busiest passenger rail stations and corridors in the country.



Freight

25 freight railroads, including Class Is like Union Pacific and BNSF and short line railroads like the San Joaquin Valley Railroad and the Arizona & California Railroad, move more than 7.2 million carloads of intermodal, food products, minerals, chemicals and other types of freight over 4,800 miles with more than 8,000 employees.



Amtrak

CA has 4 long distance routes and **3** state supported Amtrak routes, including:

- California Zephyr
- Coast Starlight
- Southwest Chief
- Sunset Limited
- Capitol Corridor State Supported
- Pacific Surfliner State Supported
- San Joaquins State Supported

More than **12** million train riders are served at CA stations each year.



Commuter

Commuter rail provides more than **35** million

passenger trips each year on the following systems:

- Caltrain in San Francisco
- Metrolink in LA
- SMART in Sonoma and Marin Counties
- ACE in San Jose
- Coaster (NCTD) in San Diego



Suppliers

SuppliersThe rail supply industry contributes more than **\$6** billion to CA's GDP and supports more than **46,000** jobs, including 10,000 direct jobs in CA through companies like Wabtec, Alstom, Siemens, **Progress Rail and TTX.**

Did you know?

It would have taken approximately 9 million additional trucks to handle the **160** million tons of freight that originated in, terminated in, or moved through CA by rail in 2017. Passenger trains also help the environment - Caltrain alone displaces the equivalent of **10,000** vehicles per day.
